Apprenticeship Application Information

The Teamsters construction drivers are expected to drive a variety of trucks that are commonly used in the construction industry, ranging from commonly recognized tractor-trailers to tractors which feature flatbeds and lowboys trailers, mixer trucks, end dump or side dump trucks, fuel trucks, water trucks, combination, and straight trucks. It's not just driving trucks, it also includes the implements on some, such as strapping or chaining down equipment or commodities to name a few.

The minimum application requirements are:

- 1.) Authorized to work in the U.S.
- 2.) Applicants must be at least 21 years of age (18 years old for diesel mechanic).
- 3.) Applicants must have a high school diploma or GED equivalency.
- 4.) Applicants must possess and maintain a valid driver's license with a clean driving record for the past five years.
- 5.) Applicants must be able to obtain a commercial driver's license in accordance with Federal Regulations and Missouri State Law.
- 6.) Applicants must have reliable transportation.
- 7.) Applicants must be physically capable of performing the essential functions of the occupation. Applicants selected for entry into the program will be required to obtain a DOT medical certificate, pass a DOT Pre-Employment drug/alcohol test and physical exam. Cost borne to applicant.

Required documents to be furnished at time application is made:

- 1.) Proof of age: valid driver's license, and or the other acceptable documentation.
- 2.) Original Birth Certificate
- 3.) Copy of high school diploma or GED certification for evaluation purposes.
- 4.) Submit a DD-214, or similar documentation used to verify military training and/or experience if they are a veteran and wish to received consideration for such training/experience.
- 5.) Current copy of your driving record (must be obtained within the last 30 days of application date).

Applicants must provide the original documents. Photocopies of the documents listed above will not be accepted. Our staff will photocopy all submitted documents.. All original documents will be returned to the applicant.

NOTE: Applications received that are unsigned, incomplete or without the necessary documentation will not be considered by the JATC Training facility office.

All applications must have an appointment to drop-off/pick-up!
